## Fujitsu & Symantec deploy Data Center Security at Banco Sabadell in Spain to protect their critical banking IT environment and to comply with Spanish PCI-DSS regulations

Banco Sabadell is Spain's fourth largest private banking group, which is comprised of different banks, brands, subsidiaries and part-owned companies covering all areas of the financial business sector under a common denominator: professional performance and quality. The company operates through 2.310 branches in Spain and in some international locations. Their 17.529 employees (end of 2014) use the most modern, up-to-date technological and commercial resources.

### Business Challenges and Fujitsu's & Symantec's Role

Financial institutes and banks such as Banco Sabadell have to comply with the Payment Card Industry Data Security Standard (PCI-DSS). This describes as set of requirements designed to ensure that companies who process, store or transmit credit card information maintain a secure environment. For Banco Sabadell security plays a critical role - not just for complying with regulation and standards but also in achieving customer satisfaction and trust.

So the bank reached out to Fujitsu and Symantec as already established business partners to address the challenges of securing their banking IT environment. The aim was to quantify risk reduction at the ATM infrastructure, decreasing user risk and assist in building a mature and secure ATM business framework.
