- Elimination of antiquated components.
 - Native Security
 - System-defined Type sequencing
 - InfoMan
 - CA ROSCOE
 - CA Netman interfaces
- Documentation published on docops.ca.com
- No new product functionality



Version 18 To-Date Review October 2015 - Incremental Delivery 1

- Approver Disqualification option
 - Provides capability to automatically have Endevor disqualify Package Approvers
 - If they modified an Element contained in the Package
 - If they created the Package
- Endevor Integration for the Natural Environment (EINE)
 - Various configuration improvements (i.e. capability to preset screen field default values)
 - Scan/Goto capability added to Display Element option



Version 18 To-Date Review December 2015 - Incremental Delivery 2

- External Security Interface (ESI) enhancement for Alter Action (from V17 backlog)
 - ESI extended to enable you to control what users can do with Alter
 - New ESI parameter introduced to provide MCF metadata field identifier
 - Rules can be built to control field updates by user
- Relaxing Element name syntax rules (Java/USS support)
 - Embedded blanks allowed in SCL Element name values
- Endevor ISPF "Changes" panel (option "C")
 - Provides documentation link to docops.ca.com/Endevor
- Simplification of Endevor Web Services configuration
 - Done because many people experiencing difficulty with this task with prior releases



Version 18 To-Date Review March 2016 - Incremental Delivery 3

- Approver Disqualification option improvement
 - Capability to activate Approver Disqualification feature by Approver Group
 - Validation partner feedback drove this enhancement
- Validation utility for of Endevor Web Services implementation
 - Endevor Web Services "echo" utility provides capability to confirm "plumbing" operational



- Version 18 To-Date Review
 March 2016 Incremental Delivery 4 (18.0.04)
- Introduction of the Incremental Delivery PTF
 - Provides roll-up of feature PTFs and published service PTFs
 - Enhanced Product Release identifier 18.0.xx



- Version 18 To-Date Review
 Anticipated April 2016 Incremental Delivery 5 (18.0.05)
- Endevor Admin Action activity SMF logging and monitoring
 - Creates SMF records for all Endevor Admin Actions
 - MCF Inventory-related definitions
 - PCF Package-related definitions
 - API, CSV and Reporting capabilities are in the release backlog
