

DB2 Utilities execution: What...

- What kind of utilities ?
 - SW provider: only 1, 2, 3,...
 - REORG: ONLINE exclusively?
 - IMAGE COPY:
 - SHRLEVEL REFERENCE/CHANGE
 - INLINE
 - RUNSTATS: stand alone or integrated in other utilities?
 - RECOVERY: never if possible...
 - LOG ANALYZER
 - Administrative: Performance / Administration

DB2 Utilities execution: Why...and for what

- Why do you execute DB2 utilities? What is the goal to achieve?
 - New business (application) requirement: CREATE
 - Update business (application) requirement: ALTER
 - DBA proactivity
 - SQL performance analysis
 - Object analysis
 - Subsystem parametrization/migration
 - DBA reactivity
 - Error condition

DB2 Utilities execution: When...

- When do you execute DB2 utilities?
 - Who decides ? Business or IT. If IT, which IT?
 - Utilities maintenance window available?
 - Deadline to execute utilities
 - Prioritization ? Which criteria: business or DBA ?
 - Parallelism: intra/extra lpars
 - System availability: CPU, work space, initiators,...
 - Subsystem parametrization/migration
 - On error condition: **ASAP !!!** But.....

DB2 Utilities execution: When...

- When do you execute DB2 utilities?
 - REORG TABLESPACE/INDEX OFFPOSLIMIT INDREFLIMIT
 - V8 nice approach to optimize REORG execution
 - OFFPOSLIMIT INDREFLIMIT values: RC 2 if conditions met...
 - V12...deprecated...use DSNACCOX
 - REORG TABLESPACE/INDEX REPORTONLY

DB2 Utilities execution: Where...and how...

- Where do you execute DB2 utilities?
 - Dedicated LPAR, in case Data Sharing
 - Exclusive LPAR shared with business application
 - Any LPAR: based on WLM rules and policies
- How do you execute DB2 utilities?
 - Job scheduler: CA-7, TDS, CONTROL-M
 - What kind of jobs manage? MF only ? Distributed also?
 - Controls: Coordination/dependencies, termination, restarting,...
