- RejectedExecutionException observed in Delivery Service which causes DS to stop sending files to Presenter.
- Fixes in the JMS Plugin for CAAlcatel5620SAM device pack for configurable parameters for JMS SSL Keystore Path and Keystore Password.
- Installation of CAMM when performed with Hostname caused MC – LC communication failure.
- Device pack File List consists Null Values which causes data to be discarded for the particular poll.
