New Features and Enhancements

The following features have been added in CA Performance Center 2.3.4 and CA Infrastructure Management Data Aggregator 2.3.4.

Platform Updates

Browser Support

CA Performance Center now supports Microsoft® Internet Explorer version 11, in addition to versions 9 and 10. For a complete list of supported browsers, see the [System Requirements](#) (see page 14).

Note: With this release, Internet Explorer version 8 is no longer supported.

Also be aware that we are advocating a new minimum screen resolution setting to avoid problems with scrolling and truncation of selected dialog boxes: 1280x1024 is the new minimum resolution setting.

Improvements to CA Mediation Manager Integration Architecture

Stand-alone CA Mediation Manager architecture to support CA Mediation Manager for Infrastructure Management improves scalability, resilience, and administration. Device pack creation and deployment have been simplified.

A migration script has been provided to help you quickly migrate device packs to the new architecture.

API Changes

Groups Web Service Improvements

Inconsistencies in terminology that affected the groups web service on the CA Performance Center server have been corrected. Any existing XML documents that you use to update groups require some minor changes.

The term "user group" is no longer used in the API and is now consistent with the product terminology ("custom group"). In addition, site group syntax has been corrected. Previously, a type of "site group" led to an error, and only a type of "site" was allowed. Here are examples of the corrected syntax, with changes in boldface text:

User group term replaced by "custom group":

VendorPriorities Web Service Enhancement

The vendorPriorities web service that supports the Data Aggregator Custom Vendor Certifications feature has a new parameter: <PriorityGroup>. Use this parameter to specify the vendor certification priority group for a vendor certification. Multiple groups can be specified, separated by commas. The vendor certification is added to the group on the Vendor Certification Priorities tab in the Data Aggregator Metric Family Administration area.

Reporting Features

Group Scorecard Views

Scorecard views display performance metrics by sub-group, for the selected group during the selected time frame. Scorecards are high-level indicators of whether measured resources are meeting service-level goals. Several new views are available to add to dashboards. These views also appear by default on the Group Context page and the Site Context page.

- CPU or Memory Utilization Scorecard
- CPU or Memory Utilization Trend Scorecard
- CPU or Memory 95th Percentile Trend Scorecard
- Interface Utilization Scorecard
- Interface Utilization Trend Scorecard
- Interface 95th Percentile Trend Scorecard
- IM Custom Group Scorecard

Inventory of Managed Items Changes

Alias Names for Monitored Devices, Interfaces, and Components

CA Performance Center now includes a script, `update_alias_name.sh`, to set alias names for monitored devices, interfaces, and components. Alias names can be set through REST web services also. Users who are given the role right to view display names or aliases for items can select which name they want displayed in their dashboards and views.

Rebalance Data Collector Load

As a Data Collector instance monitors more devices, the Data Collector capacity can be exceeded and the Data Collector can become overloaded. You can now transfer the work load from one overloaded Data Collector instance to other Data Collector instances.

Device Details

You can now view details for monitored devices from the Monitored Devices view in Data Aggregator. Details include the device IP address, associated SNMP profile, the status of the device, and so on. You can also edit the IP address, Data Collector host, SNMP profile, and SNMP version for the device.

Additional Device Properties

New device properties have been included in this release: contact, location, sysobject id, vendor, and model. You can create rules on these properties, you can group by these properties, and you can view additional information about these properties.

User Interface Changes

Adding IP Domains

When you add an IP domain, the parameters to set device name aliases and interface description overrides are still available in the user interface. However, a more efficient way to set these parameters is to use REST web services. See the *CA Performance Center Web Services API Guide* for more information. You can also use the `update_alias_name.sh` script that is now included with the product, to set alias names for interfaces and components across multiple monitored devices and to set alias names for multiple monitored devices.

Usability Enhancements

Metric Family and Vendor Certification Consolidation

With the addition of vendor certification groups, metric families are easier to manage. When you select metric families for monitoring profiles or for custom data views, the list is more concise. You can more easily monitor multiple, related components on a single device

The requirement to add a metric family for each new supported MIB has been eliminated. Now multiple vendor certifications that are associated with a single metric family can be applied simultaneously. Such vendor certifications are grouped in the user interface and prioritized together.

Two metric families have been deprecated: Alternate CPU, and Alternate CPU1. They are still supported after upgrades, however.

Meaningful File Names for Exported PDFs and CSVs

With this release, CA Performance Center uses the name of the dashboard as the default name of an exported PDF. The default name of an exported CSV file consists of <dashboard name>_<view name>. In previous releases, only the page ID was used as the name of the PDF and the CSV. The new naming convention makes it much easier to identify the contents of exported PDFs and CSVs.

Dashboard Identification for Scheduled Email

With this release, CA Performance Center now identifies the name of the dashboard in the list of email schedules on the Manage Scheduled Emails page. The name of the dashboard also appears in a new read-only Dashboard field on the Email Dashboard dialog. In previous releases, the dashboard name appeared only in the Subject line of the email, which became the file name of the PDF attached to the email. If a user changed the text of the Subject line -- and removed the name of the dashboard in the process -- the identity of the dashboard was lost.

Debugging Feature

CA Remote Engineer (CARE)

With this release, CA Infrastructure Management installs the CARE tool on all CA Infrastructure Management components. CARE collects data that a CA Support Engineer uses for debugging purposes. For information about running CARE, see the "Logs and Troubleshooting" chapter of the *CA Performance Center Administrator Guide*.

Deployment Options

Any CA Performance Center deployment requires additional servers to host data sources. Data source system requirements vary widely. Consult the data source Release Notes for deployment guidelines and system requirements.

CA has performed comprehensive testing of three different deployment scenarios with different numbers of managed items. The number of managed items translates to a rate of metric data that is processed:

- 15,000 metrics per second; 100,000 managed items (smaller deployment)
- 75,000 metrics per second; 500,000 managed items (medium-size deployment)
- 150,000 metrics per second; 1,000,000 managed items (large deployment)

The system requirements in this document reflect the differing requirements of these three environments.

System Requirements

Prepare a dedicated server for the CA Performance Center installation. Be sure that the server meets the requirements for your deployment size.

For All Deployments

The software can be installed in any filesystem to which the root user has write access. Typically, it is installed in /opt.

Verify that Security Enhanced Linux (SELinux) is disabled on the server where you plan to install CA Performance Center. By default, some Linux distributions have this feature enabled, which does not allow the product to function properly.

By default, the MySQL database is installed to /opt/CA/MySQL/, but you can select another location. Make sure you have enough disk space allocated to the selected filesystem to support a database.

The minimum supported screen resolution is 1280x1024.

DNS resolution and time synchronization are required. For more information, see the *Installation Guide*.

Adobe® Flash® must be installed on any client that accesses the product user interface. You can download it from the Adobe website.

A web browser is required. The following browser applications are supported:

- Microsoft Internet Explorer versions 9, 10, 11
- Mozilla Firefox (current version)
- Google Chrome (current version)

Configure UTF-8 Support

Configure the computer where you will install the component to support UTF-8 encoding. If UTF-8 encoding is not enabled, characters may not display properly during the installation.

The appropriate language packs are also required to support localized deployments.

Note: Some scripts that are used in the installation of selected components are not localized and run in English. For more information, see the *Localization Status Readme* file.

Follow these steps:

1. Do one of the following steps:

- a. Type the following command from a Korn or bash shell:

```
export LANG=LANG_value ; export LC_ALL=$LANG
```

LANG_value

Indicates the value of the language you want the product to support. The following variables are supported:

English: en_US.utf8

French: fr_FR.utf8

Japanese: ja_JP.utf8

Simplified Chinese: zh_CN.utf8

Traditional Chinese: zh_TW.utf8

For example:

```
export LANG=zh_TW.utf8 ; export LC_ALL=$LANG
```

- b. Type the following command from a Bourne shell:

```
LANG=LANG_value ; export LANG
```

LC_ALL=LANG_value ; export LC_ALL
```

For example:

LANG=zh_CN ; export LANG

```
LC_ALL=zh_CN ; export LC_ALL
```

The language variable is set.

Version Compatibility

CA Performance Center 2.3.4 uses code and user interface design features derived from CA NetQoS Performance Center version 6.1. However, the two products are distinct in multiple ways, and they do not support the same data sources.

CA Performance Center is fully compatible with the following CA Technologies products:

- CA Network Flow Analysis
- CA Application Delivery Analysis
- CA Unified Communications Monitor
- CA Spectrum

The CA Event Manager data source that is installed automatically with the CA Performance Center software is the only version that is compatible with CA Performance Center 2.3.4.

Some CA products do not yet offer support for CA Performance Center 2.3.4. Compatibility with NetQoS Performance Center does not ensure support for CA Performance Center.

For the following product versions, **CA NetQoS Performance Center version 6.1** (or version 6.1 with service packs) is required:

- Transaction Insight Manager (TIM) on the CA Multi-Port Monitor (CA APM and CA Multi-Port Collector convergence)

If you plan to deploy TIM on the Multi-Port Monitor, NetQoS Performance Center 6.1 is *required*. Later versions are not supported.

- CA SuperAgent versions 8.3, 9.0
- CA NetVoyant versions 6.1, 7.0, 7.1
- CA ReporterAnalyzer versions 8.3, 9.0

- CA Unified Communications Monitor versions 3.0, 3.1, and 3.2
- CA Anomaly Detector versions 2.1, 2.2
- CA Event Manager version 2.1
- CA Spectrum version 9.2.1 H06
- CA Spectrum Infrastructure Manager r2.5 (with Version 1 of the CA Catalyst Connector for NetQoS Performance Center)
- CA eHealth versions 6.2.2 and 6.3

Maximum Data Source Instances Supported

CA Performance Center is capable of managing multiple instances of selected data sources. The following limits apply to the number of data sources that you can register of each type:

- 10 CA Application Delivery Analysis data sources
- 1 CA Network Flow Analysis data source
- 4 CA Unified Communications Monitor data sources
- 1 CA Application Performance Management data source
- 1 CA Catalyst Connector data source
- 1 Event Manager data source
- 1 CA Spectrum data source
- 10 CA eHealth data sources (standalone CA eHealth systems or, for CA eHealth clusters, designated front-end systems)

Important! Additional data sources can add significant load to the system. As you add multiple instances of a data source, keep track of the estimated number of managed items that they monitor. Keep the total system load at or below 1,000,000 managed items from all data sources.

Language Support

The present version of CA Performance Center supports the following locales:

- Chinese (Simplified)

Chapter 3: Upgrade Requirements and Considerations

If you are upgrading Data Aggregator, review the following information.

Supported Upgrade Paths

If you are upgrading from a previous release of Data Aggregator, upgrade your components. You always upgrade the CA Performance Center, Data Aggregator, and Data Collector components. Upgrade CA Infrastructure Manager Data Repository when you are upgrading to the releases identified in the table that follows.

Important! If you are upgrading from Release 2.0.00 to Release 2.3.3, upgrade to Release 2.1.00, upgrade to Release 2.2.x, and then upgrade to Release 2.3, first.

The following table indicates the supported upgrade paths and indicates which components to upgrade:
