
What is the CA Service Advisory Program?

- Beginning May 11, CA Technologies will begin communicating SaaS Service related advisories (Service Incident, Planned/ Emergency Maintenance and Service Releases/Upgrades information) leveraging Everbridge's Mass Notification Platform
- In order to receive these important communications, please
 follow the registration instructions in this presentation



Why Everbridge?

- Our customers prefer receiving advisories via multiple channels (Email, Mobile App, Phone, SMS text)
- CA is partnering with Everbridge, a leader in the mass communication technology space
- CA has enabled Single Sign On from your CA account, so it's even easier to access and set your notification preferences



Important information:

- 1. CA will use the above notification channels for the listed service advisories
- 2. Customer contacts must have relevant information for the appropriate channel to receive notifications
- 3. The system will try to reach customers regardless of time of day based on their channel preference set and per the above guidelines
- 4. Depending on country/region, certain carrier networks may impose SMS text charges

- New Customers will have their service and contacts provisioned by the Account Team during the implementation phase both in the support tool as well as the CA Service Advisory Program





- Access CA Service Advisory Member Portal at: <u>http://memberportal.ca.com</u>
- You will be redirected to ca.com for your username and password that you used to register at ca.com
- Once authenticated, you will be redirected to the CA Service Advisory Member Portal that will allow the contact to set preferences/configure subscriptions
- All advisories are enabled and mandatory for all contacts
- Should you be logged out of the Member Portal, you can login by selecting the 'Use My Network Credentials' on the logout page or by typing the URL (<u>http://memberportal.ca.com</u>) in your browser



Mobile Member App

- We strongly recommend and encourage our customers to use the Everbridge's Member Mobile App to receive service advisories
- The Mobile App leverages push notifications (requires WiFi at a minimum) making it much more reliable and cost effective than SMS Text
- IOS and Android devices are supported
- From the mobile device browser, access CA Service Advisory Member Portal at <u>http://memberportal.ca.com</u> -> select My Profile -> select Edit-> Follow the link to download the app at the bottom of the page

Mobile Member App

- Once the app is downloaded to the mobile device, select 'Enable Single Sign On' on the app login screen
- Enter the Single Sign On key phrase to register the device. The key phrase is case sensitive


- You will be redirected to ca.com for the username and password used during the registration process at ca.com



FAQs

- What if I'm already registered with CA Support?

FAQs

- Could customers use Distribution Lists to receive notifications?
 - While technically advisories can be sent to a distribution list, we do request customers to register individual contacts due to the different channels and delivery methods involved
- What is the Mobile App key phrase?
 - The key phrase is CAMobile1
- Do I need to also register as an Everbridge user in the CA Service Advisory Member Portal?
 - No, you should not register as an Everbridge user as that option is for customers who have deployed the service without Single Sign On.



FAQs

- What browsers are currently supported?
 - Internet Explorer (versions 9 & 10); Chrome; Firefox
 - Everbridge has limited support for IE 7 & 8 for the Member Portal and hence not recommended
- Mobile App and Android device logout resulting in 'Account already exists when the 'back' button is selected?
 - This is a known issue. If you have logged out and receiving this message, you can reboot your device and attempt to access to application. You should not be prompted to configure Single Sign On.
 - If you are in the process of logging out of the Mobile App on an Android device, then please select 'Done' and confirm that you want to exit by selecting 'OK'. The next login event will log you into the application without being prompted to configure Single Sign On.
