CA Technologies made several ground-breaking company

announcements at CA World. We've highlighted the Security announcements below.

- <u>CA Threat Analytics for PAM</u>, which integrates with CA Privileged Access Manager (PAM) and uses advanced behavior analytics and machine learning to detect and mitigate threats coming from privileged user accounts.
- <u>CA Identity Service</u> is a SaaS offering that addresses the need for a modern, hybrid IAM solution – giving businesses the agility to quickly and securely adopt cloud applications and services and manage them from a single launch pad alongside their on-premises applications controlled by CA Single Sign-On.
- <u>CA Identity Suite</u> which includes Deployment Xpress to dramatically streamline deployment of identity use cases. It adds to the deployment simplicity that was introduced with the Virtual Appliance. It also includes integration with CA Privileged Access Manager (PAM) to provide governance of privileged accounts.

The CA SSO Product team is pleased to announce the general availability of CA SSO 12.6

CA announced the General Availability of CA Single Sign-On on November 30th. Within this release, we focused on three core themes: Expanded Capabilities; Simplified Operations & Manageability; and Reduce Cost of Ownership. Enhancements include certification management for federated partnerships and administrative search for agents. The release also saw the migration to a 64-bit platform and support for Red Hat 7, both of which are showing significant performance gains during internal benchmark testing. Finally, we helped to reduce total cost of ownership further by removal of the risk engine server component to support enhanced session assurance; this capability has been built into the CA Access Gateway.
